Re: Grave concerns over the role of your company, Omni Air International, in the deportation of black immigrants from the USA to Cameroon, where they could be illegally detained, tortured, or killed.

Dear Jeff and Rich,

I am writing on behalf of TASSC International and other organizations signing on this letter, about our grave concerns over the mass, sudden deportation of African asylum seekers by the U.S. government. This precipitous action will almost certainly result in the unlawful torture, incarceration, and perhaps the death of many innocent individuals. Any involvement by your company in these deportations makes Omni complicit in a shocking violation of basic international human rights law. We trust that, as an airline company with a trusted reputation, you would want to be made urgently aware of this situation. TASSC, the Torture Abolition and Survivors Support Coalition International (TASSC) was established to meet the needs of survivors of torture and persecution and to advocate for the prevention of torture and support for its survivors. Since 1998, TASSC has served more than 7,000 torture survivors from more than 72 countries. TASSC provides an array of services, including social services, counseling, legal representation, workforce development, and advocacy to end torture worldwide.

In recent years, we have seen an alarming increase in the number of survivors of torture and persecution by the government of Cameroon and its collaborators. However, it is asylum seekers from this very nation who are now targeted by ICE for mass deportation and a return to the torture and persecution from which they fled. We understand that your company was responsible last week for transporting a plane filled with these persecution survivors back to the brutal conditions of their home country. We also understand that further flights may be planned, leading to the mass deportation of more black African asylum seekers. We hope that, once you and your company understand the dire implications of these actions, you will cease to participate in them.

TASSC, working with other concerned human rights organizations, has amassed overwhelming evidence of the torture and persecution of innocent persons from Cameroon whose only “offense” is their opposition to widespread political oppression and violence on the part of their government and regime supporters.

With no choice but to flee their home countries to escape torture and persecution, increasing numbers of asylum seekers from Cameroon have made arduous journeys to the U.S. border to obtain refuge under basic U.S. and international human rights laws.

Sadly, there is also mounting evidence that their treatment at the border and in U.S. detention breaches well-settled legal principles, even including the use of physical violence, pepper spray, and threats by ICE agents and contractors to force these asylum seekers into deportation.

TASSC respectfully requests the opportunity to talk with you about these gross human rights violations and to provide your company with the accumulated evidence of the torture and persecution of Cameroonian individuals both in their home country and in ICE custody. We ask as well that you immediately suspend any cooperation with ICE that your company may be contemplating in the near future until you have had the opportunity to review this evidence. We are confident that, after you consider the facts, your company will step back from any further participation in this human rights scandal.

I will be in touch with you soon to arrange a virtual meeting to discuss this crisis and provide you with the evidence that you need to be sure that further decisions regarding your company’s involvement with the mass deportation of Cameroonian asylum seekers is guided by simple decency and regard for basic human rights. Thank you very much for your consideration, and I look forward to speaking with you.
